SECTION 2: FUNCTIONS. The Barangay Development Council shall have the following functions:

1. Mobilize people participation in local development efforts;
2. Prepare Barangay Development plans based on local requirements;
3. Monitor and evaluate the implementation of National and Local programs and projects;
4. Conduct meeting once every six months or as often as may be necessary;
5. Perform such other functions as may be provided by law or competent authority.

SECTION 3: BDC SECRETARIAT, The LDC Secretariat is hereby created to be headed by the Punong Barangay as Chairman, a representative by the Sangguniang Barangay to be chosen from among its members, and a representative of NGO that are represented in the BDC as members.

SECTION 4: EFFECTIVITY. This Executive Order shall take effect immediately and shall supersede any issuances inconsistent to this order.
