EXECUTIVE ORDER NO. 019, SERIES OF 2023-2025
AN EXECUTIVE ORDER DESIGNATING HON. ARMANDO RAY V. FAJARDO,
SANGGUNIANG BARANGAY MEMBER, AS SENIOR CITIZENS FOCAL PERSON OF
BARANGAY KAMUNING.

WHEREAS, according to Declaration of Principles and State Policies of the Philippine Constitution, mandates that the State shall promote social justice in all phase of national development;

WHEREAS, the same constitution includes senior citizens as one of the priority sectors to be given access to essential goods and services at affordable cost;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as a Local Government Code of 1991 states that the Local Government units, shall ensure and Support among other things the preservation and enrichment of cultures, promote health and safety, enhance economic prosperity and social justice, promote full employment among residents, maintain peace and order and preserve the comfort and convenience of inhabitants;

NOW, THEREFORE, I, ARMIDA F. CASTEL, Punong Barangay, of Barangay Kamuning, District IV, Quezon City, by virtue of the power vested in me by law, hereby order:

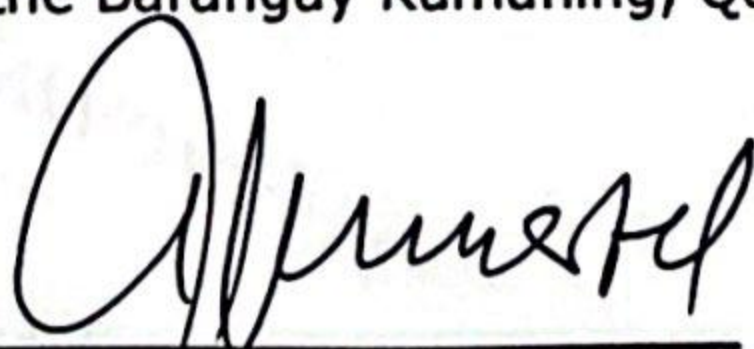
SECTION 1. HON. ARMANDO RAY V. FAJARDO, SANGGUNIANG BARANGAY MEMBER, is hereby designated as Senior Citizen Focal Person.

SECTION 2. Roles and Responsibilities:

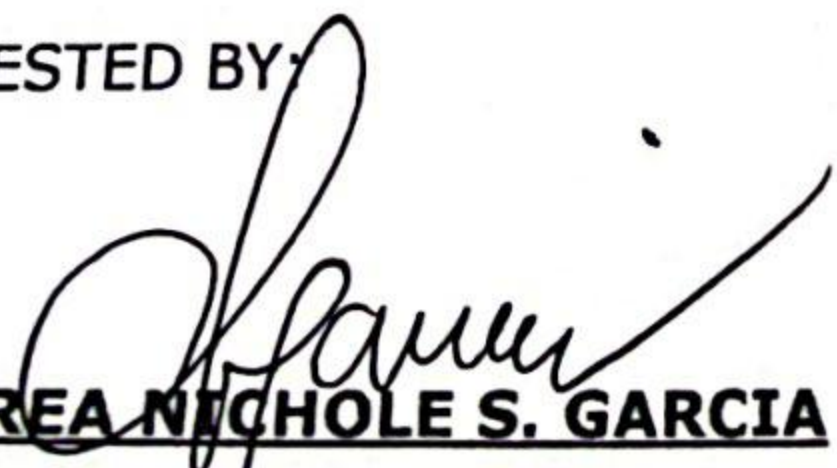
- Implement the pre vision of the Magma Carta for Senior Citizens and its amendments in the Barangay Level;
- Establish data gathering for statistic of Senior Citizen for seminars /trainings, livelihood and job opportunities and serve as information desk of Barangay;
- Monitor and regulate fund raising activities and solicitations using Senior Citizen as beneficiaries;
- Assist Senior Citizen's to have access to voting precincts during local and national election's; and
- Submit reports to the Punong Barangay and Committee Chairman on Senior Citizen Affairs relative to the activities of the Senior Citizen sector.

SECTION 4. EFFECTIVITY. This order shall take effect immediately and shall supersede any issuances inconsistent to this order.
