REORGANIZATION OF THE BARANGAY NUTRITION COMMITTEE (BNC).

WHEREAS, Article XV, Section 3(2) of the 1987 Constitution states that: "The State shall defend the right of the Children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to development;

WHEREAS, Presidential Decree No. 491 S-1974, the Nutrition Act of the Philippines, declared that nutrition is now a priority of the government to be implemented by all branches of the government in an integrated fashion and that the National Nutrition Council is created to provide programs for under the Philippine Food and Nutrition Program;

WHEREAS, Presidential Decree No. 1569 implemented the creation of the Barangay Nutrition Program under the administration of the National Nutrition Council;

WHEREAS, DILG Memorandum Circular No. 2018-02 dated March 26, 2018 requiring the activation / reactivation of Nutrition Council at the Barangay Level in order to be viable, functional and effective in the integration / implementation of nutrition programs and activities into Barangay Development Plans;

WHEREAS, the Barangay Nutrition Committee's function is to formulate action plan programs, coordinate and monitor nutrition activities, conduct periodic field visit and meeting to access program implementation, serves as resource group and come up with nutritional action plan;

NOW, THEREFORE, by virtue of the power vested in me by law, I, **Armida F. Castel**, Punong Barangay of Barangay Kamuning, District IV, Quezon City, do hereby orders the reorganization of Barangay Nutrition Committee with specifics as follows:

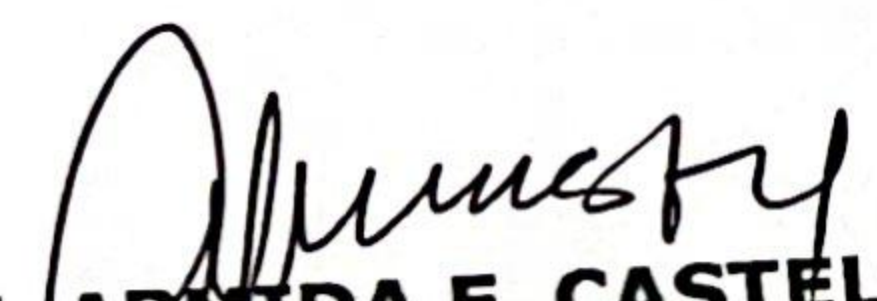


SECTION 3: ACTION OFFICER. The Barangay Nutrition and Action Officer shall oversee the implementation and delivery of nutrition and other related services such as but not limited to food supplementation, backyard food production, environmental sanitation, livelihood and home gardening.

SECTION 4: MEETING. This committee shall meet every first Friday of the month or as may be called upon by the Chairperson.

SECTION 5: EFFECTIVITY. This Executive Order shall take effect immediately and shall supersede any issuances inconsistent to this order.
