REORGANIZATION ON THE CREATION OF THE BARANGAY COUNCIL FOR
THE PROTECTION OF CHILDREN (BCPC).

WHEREAS, in furtherance of the goals of the Child and Youth Welfare Code or Presidential Decree No. 603, DILG Memorandum Circular Nos. 90-40 and 91-07 and to ensure the full implementation of the rights of every child to live in a society that offers or guarantees him a safe, healthy, good morale environment and facilities for his wholesome development, it is essential that Barangay Council for the Protection of Children (BCPC) be created and constituted.

NOW, THEREFORE, by virtue of the power vested in me by law, **ARMIDA F. CASTEL**, Punong Barangay, of Barangay Kamuning, District IV, Quezon City, due hereby orders the reorganization the BCPC.

Section 1. This Executive Order shall be known as "The Council for the Protection of Children."

Section 2. There is hereby created the Barangay Council for the Protection of Children (BCPC) which shall perform the following duties and functions:

1. To foster the education of every child and young people in the Barangay, assure that every child should have at least secondary education;
2. To encourage proper performance of the duties of parents and provide learning opportunities on the adequate rearing of the children and on positive parent-child relationship;
3. To report all cases of child abuse to the proper authorities;
4. To protect and assist abandoned, maltreated and abused children and facilitate in their cases filed against child abusers;
5. To prevent child labor in their area and to protect working children from abuse and exploitation;
6. To take steps to prevent juvenile delinquency and to assist children with behavioral problems so they can get expert advice;
7. To adopt measures to promote the health and nutrition of the children;
8. To promote the opening and maintenance of playgrounds, reading and learning center, day care centers and other services necessary for child and youth welfare;
9. To secure the cooperation of organization devoted to the welfare of children and coordination their activities;
10. To promote wholesome entertainment in the community;
11. To assist parents whenever necessary in securing expert guidance counseling from the proper governmental or private welfare agencies;

12. To advocate for the passage of child-friendly Barangay Ordinances in response to child related issues and concerns;
13. To prepare the Barangays Plan of Action for Children which address the needs of the Children in the community and ensure their integration into the Barangay Development Plan and Implementation by the Barangay;
14. To submit quarterly Barangay Accomplishment Reports on the implementation of the plan to the C/MCPC;
15. To perform other related responsibilities as may be assigned by law or competent authorities.

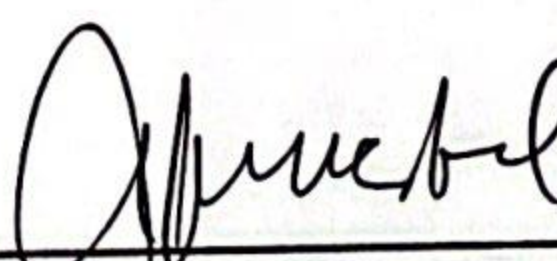
SECTION 3. The BCPC shall be composed of the Punong Barangay and Chairperson, the Chairperson of the Sangguniang Kabataan as Vice Chairperson and the following as members:

1. Barangay Kagawad Chairperson on Children, Women and Family
2. Barangay Nutrition Scholar
3. Barangay Day Care Center
4. Barangay Health Nurse / Midwife
5. Barangay Health Worker
6. Dep-Ed Principal / Teacher-in-Charge
7. Chief Tanod / BPSO Executive Officer
8. Chief of Police / Duly Authorized Representative
9. Sangguniang Kabataan Chairperson Children's Representative
10. PTA / President or Representative
11. Others

The Punong Barangay may appoint other members of the Council depending on the need and circumstances.

SECTION 4. EFFECTIVITY. This order shall take effect immediately and shall supersede any issuances inconsistent to this order.
